### < Rental car Terms of Use >

- The customer requires keep the rental agreement while driving the rental car. Please show the rental agreement to a police officer or member of the Land Transport Office of District Bureau when they requested.**
- If the customer uses the rental longer than two days, the customer requires checking oil, water, fan belt, brake pedal, underbody, etc.
- When the rental cars have mechanical problems, Eco-la Rental Car (ERC) will try to support the customer in timely mater; however, ERC will notcover the damage which caused by the mechanical problems. ERC also has no loaner to change the rental car. If you have problem with the rental car, please contact Japan Automobile Federation (JAF) dial #8139 with push phone or mobile phone, PHS.
- Please contact when you have mechanical problems or accident. If the customer does not notify us and takes the rental car to the undesignated repair shop where ERC has no contract, ERC cannot disburse the repair cost.
- When the customers have an accident or single car accident, please notify to the police. If the customers fail to report to the police, the customer will not be able to claim the insurance or compensate for the damage of the accident.
- When the renter or the driver violates parking law, the renter will be fully responsible for pay the fine which includes toll fee and other cost for the violation.
- Insurance and compensation policy (Insurance fee of disclaimer;1575yen for a day)
  - Third-party liability coverage: For per person unlimited (include auto mobile liability insurance)
  - Property damage coverage: Unlimited (deductible amount 50,000 yen)
  - Rental car damage liability coverage: Per accident current value (deductible amount will be 50,000 yen)  
Amount of damage: (deductible amount will be 50,000 yen)
  - Passenger coverage: Death 10 million yen for per passenger. Hospitalized 7,500 yen a day, medical fee 50,000 yen a day. For prognostic symptoms, it will evaluate the condition of symptoms; however, maximum amount will be 10 million yen. Maximum coverage of hospitalization or ambulatory will be 180 days.
  - \*Insurance coverage and compensation will not compensate the following condition;
    - If the driver has no contract with ERC and he/she gets in an accident.
    - The renter has accident involving alcohol or involving other unlawful activities.
- The renter will be responsible for the non operation charge for the following cases:
  - When the renter cannot return the rental car due to involving accident, theft or repair of the rental car.
  - Toll fee will be reasonable for the renter.
    - (1) If the renter returns to expect rental store, the renter will be charge 20,000 yen
    - (2) If the renter exceed contract days, the renter will be charge 50,000 yen
    - (3) If the rental car has completely damage, the renter will be charge 100,000 yen
    - (4) If the rental car got a flat tire, damage to the wheel cap, missing hubcap, the renter will be charge 5,000yen
- Non-Operation charge compensation [ Optional KC class: 500 yen for a day, NJW class 800 yen for a day ]  
 During the contract period, the renter involves in accident, the renter will be responsible for non operation charge; however, if the renter signed up non-operation charge, it will reduce of the cost.  
 When the accident occurred and could not identify the other party, or damage inside the vehicle, the charge will be half amount.
  - (1) If the renter returns to the expect rental, it will cost 10,000 yen
  - (2) If the renter exceed due days, it will cost 25,000 yen
  - (3) If the rental car has completely damage, it will cost 50,000 yen
  - (4) If the rental car got a flat tire, damage to the wheel cap, missing hubcap, the renter will be charge 5,000yen  
(Non-Operation charge compensation not covered.)
- When renter smoked inside the rental car, the renter requires paying 20,000 yen for cleaning.
- Please contact us prior when delay to return the rental car. We requires to charge from the renter for extend fee.
